

Information about the processing of your personal data

The lawful processing of personal data is important for the University of Veterinary Medicine and Pharmacy in Košice (hereinafter referred to as "UVMP") and their protection is a matter of course. Purpose of processing your PD: study at UVMP

1. Legal basis for your PD processing:

- within extent defined in Act no. 131/2002 Coll. on Higher Education Institutions and on Amendments to Certain Acts, as amended,
- Act no. 18/2018 on the Protection of Personal Data and on the Amendment of Certain Acts.

Retention period of your data as a student at UVMP in Košice: 50 years in the student register from the end of the study of the data subject according to the Act no. 131/2002 Coll. on Higher Education Institutions and on Amendments to Some Acts, as amended

2. Processing of your PD based on your given consent:

Retention period of your data as an applicant not yet registered to study/person interested in information about the UVMP in Košice: until withdrawal of your consent

- rectification of PD;
- removal of or limiting the processing of the PD (if possible);
- refute the processing of the PD;
- portability:
- withdraw their consent whenever they wish (if possible);
- file a complaint at the Office for the Protection of Personal Data according to the Section 100 of the Act.
