Announcement of a selection procedure for the position of associate professor at the University of Veterinary Medicine and Pharmacy in Košice

The Rector of the University of Veterinary Medicine and Pharmacy in Košice pursuant to Section 77, par. 1) and par. 2) of the Act. No. 131/2002 Coll. as amended

**hereby announces a selection procedure
for the position of associate professor
in the field of study “Veterinary Medicine”**

The position of associate professor is open at the University of Veterinary Medicine and Pharmacy in Košice, Komenského 73, 041 81 Košice.

Qualification requirements and special qualification requirements for performing the position: completion of third-level university education and meeting the criteria for obtaining the title of associate professor at the University of Veterinary Medicine and Pharmacy in Košice.

Other criteria and requirements in connection with the position: Meeting the requirements for the position of associate professor at the University of Veterinary Medicine and Pharmacy in Košice according to the Internal Rule the General criteria for filling the positions of professor and associate professor at the University of Veterinary Medicine and Pharmacy in Košice and submission of a development plan for a period of five years in the scope of a maximum of five pages in the field of study “Veterinary Medicine” with a focus on the specifics of the area in which the selected applicant will fulfill the pedagogical and scientific-research mission (infectious diseases of animals).

List of required documents and attachments to the selection procedure:

- application for the participation in the selection procedure
- structured professional CV, including data according to Section 76, par. 9, letter a) of the Act. No. 131/2002 Coll. as amended
- copies of documents proving their education and the acquisition of scientific and pedagogical degrees
- confirmation of continuous teaching practice of at least 780 hours
- a written affidavit of integrity
- an overview of publication activities prepared in accordance with Annex no. 1 of the Decree of the Ministry of Education, Science, Research and Sport of the Slovak Republic No. 456/2012 Coll., for the last 5 years
- list of scientific research projects.



- output from fulfilling the requirements according to the Internal Rule the General criteria for filling the positions of professor and associate professor at the University of Veterinary Medicine and Pharmacy in Košice
- development plan for a period of five years in the scope of a maximum of five pages in the field of study “Veterinary Medicine” with a focus on infectious diseases of animals.

Applicants submit copies of documents proving their education and the acquisition of scientific and pedagogical degrees, academic titles and confirmations of certificates of continuous pedagogical activities.

Date and place of submission of the application for the selection procedure: the applications may be submitted until May 18th 2026 at the Legal and Human Resources Department or to the Post Room of the University of Veterinary Medicine and Pharmacy in Košice.

Information on salary conditions: according to the valid legal regulations in accordance with Act No. 553/2003 Coll. on the remuneration of certain employees in the performance of work in the public interest, as amended, the salary ranges from € 1874 to € 2 297,50.

Information on the processing of personal data in the selection procedure: the personal data of unsuccessful applicants will be sent to the sender’s address indicated in the application in accordance with the GDPR and the Personal Data Protection Act, as amended.
