RECTOR'S DIRECTIVE No. 2/2021

in connection with the Resolution of the Government of the Slovak Republic No. 832 of January 17th 2021 on the proposal for adoption of measures to reduce COVID-19 disease in the territory of the Slovak Republic and for the change of measures taken pursuant to Article 5 par. 4 of the Constitutional Act No. 227/2002 Coll. State Security at the Time of War, State of War, State of Emergency, and State of Crisis, as amended

I hereby order:

- 1. All employees of workplaces will perform work from home from January 25th 2021 to February 7th 2021, with the exception of those employees who must necessarily perform urgent work at the workplace in the period until February 7th 2021.
- 2. Employees and PhD students, who in the period from January 25th 2021 to February 7th 2021 will perform the work only from home according to the instructions of the head of their workplace, are obliged to be available via electronic and telephone connection and, if necessary, to come to the workplace.
- 3. Necessary and continuous operations remain at clinics, special facilities, Finance Department, Information and Communication Technologies, Department of Safety and Crisis Management and Operation and Investments Department, in order to ensure their tasks according to a schedule of shifts.
- 4. Employees and PhD students, who in the period from January 25th 2021 to February 7th 2021 will perform the work at the workplace, must have a certificate with a negative test result for COVID-19 (RT-PCR or antigen test), which was performed from January 18th 2021, or proof of a recovery from COVID-19 disease not older than three months, or proof of a vaccination against COVID-19 with a second dose of vaccine if at least 14 days have passed since this vaccination. The regime in the period from February 3rd 2021 to February 7th 2021 will be determined by an amendment to this directive on the basis of reported degree of positivity in individual districts by the Ministry of Health of the Slovak Republic.
- 5. Heads of the workplaces must ensure control of the certificates and documents referred to in par. 4.
- 6. Heads of the workplaces must ensure organizational and administrative operation of the workplace in such a way so as to minimize contact between employees.
- 7. In the period from January 25th 2021 to February 7th 2021 I cancel the attendance (in person) form of teaching.
- 8. On-line teaching via MS Teams system for 6th year students of General Veterinary Medicine (including post BSc.) takes place according to the instructions from December 14th 2020, published on the university website: <u>http://www.uvlf.sk/en/news?item=1430</u>.

This order shall enter into force and effect on January 21st 2021 and shall be valid until February 7th 2021.
