

**Announcement of the Election of the Candidate for the Position of Rector of University
of Veterinary Medicine and Pharmacy in Košice
for the Term of Office from 1 February 2027 to 31 January 2031**

The Academic Senate of the University of Veterinary Medicine and Pharmacy in Košice, pursuant to Section 10(5) of Act No. 131/2002 Coll. on Higher Education Institutions and on Amendments and Supplements to Certain Acts, as amended, Articles 5 of the Statute of the University of Veterinary Medicine and Pharmacy in Košice, and Internal Regulation Rules for the Election of the Candidate for the Position of Rector and for the Adoption of a Proposal for the Dismissal of the Rector of University of Veterinary Medicine and Pharmacy in Košice (hereinafter referred to as the “Rules for the Election of the Rector Candidate”), hereby announces the election of the candidate for the position of University of Veterinary Medicine and Pharmacy in Košice for the term of office **from 1 February 2027 to 31 January 2031**.

The election of the candidate for the position of Rector of UVMP will take place at a meeting of the Electoral Assembly **on 22 October 2026 at 14:00** in the Aula of UVMP (building no. 34), Komenského 73, Košice.

The period for submitting nominations for candidates for the position of Rector of UVMP is **from 7 July 2026 to 8 October 2026 until 14:00**.

The right to submit nominations for candidates for the position of Rector of UVMP is vested in members of the academic community of University of Veterinary Medicine and Pharmacy in Košice and members of the Board of Trustees of the University of Veterinary Medicine and Pharmacy in Košice.

A proposal for a candidate for Rector of UVMP shall be submitted in writing using the form which constitutes Annex No. 1 to this announcement. The proposal must be accompanied by the written consent of the proposed candidate with the candidacy in the election for the Rector of UVMP, using the form which constitutes Annex No. 2 to this announcement. The candidate is required, within the period designated for the submission of nominations, to submit their curriculum vitae, their proposal for the development strategy of the University of Veterinary Medicine and Pharmacy in Košice and their a criminal record check issued within the last three months (hereinafter referred to as the ‘accompanying documents’). The accompanying documents shall be submitted exclusively in printing form.

Nominations and also the accompanying documents shall be addressed to the Chairman of the Academic Senate University of Veterinary Medicine and Pharmacy in Košice and submitted via the Registry Office of University of Veterinary Medicine and Pharmacy in Košice in a sealed envelope marked with the sender and labelled “DO NOT OPEN - Election of the Candidate for the Rector of UVMP”.

The public hearing of candidates for the position of Rector of UVMP will take place at a meeting of the Electoral Assembly of University of Veterinary Medicine and Pharmacy in Košice **on 19 October 2026 at 14:00** in the Aula of UVMP (building no. 34), Komenského 73, Košice.
